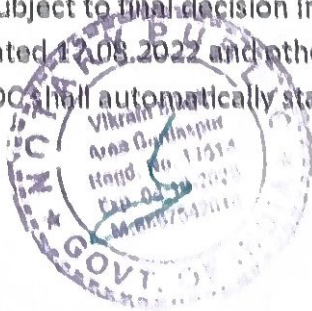

With reference to the above subject, your application bearing Petition & Application No. EA632F2411 has been considered.

1. This Department has no objection if the school is affiliated with the Central Board of Secondary Education (CBSE), Gurdaspur, Directorate School Education (Sec.), Punjab, Mohali, subject to compliance with instructions issued by the Department of School Education, Punjab Government, vide letter dated 26.11.2018 and para 6 therein.
2. The NOC is granted subject to the following conditions:
 - a) The Department of School Education, Punjab Government shall have the right to withdraw this NOC in case of violation of Punjab Education Act, 2009, Right to Free and Compulsory Education Act, 2011, Punjab Regulation and Other Allied Education Institutions Act, 2016 and other instructions/rules issued by the Department from time to time.
 - b) The provisions of the Punjab School Education Act, 2008 and other related laws shall be applicable to the school.
 - c) The school management shall strictly comply with the instructions of the Department of School Education, Punjab, as well as with those issued by the Government of India.
 - d) The school shall not charge any capitation fee and shall not indulge in profiteering in the name of education.
 - e) Admission shall be made without any discrimination of caste/creed/religion and seats shall be reserved for children belonging to weaker sections and disadvantaged groups as per RTE Act, 2009.
 - f) The school shall abide by the conditions and rules mentioned in the letter issued by the Department of School Education, Punjab, dated 26.11.2018 (para 8).
 - g) This NOC shall be subject to final decision in CWP No. 17967 of 2022 pending before the Hon'ble High Court dated 12.08.2022 and other connected matters. If the Court passes an adverse order, this NOC shall automatically stand cancelled.



3. The NOC issued by this Department shall not be used in any court for any legal proceedings.
4. This NOC shall be subject to final approval of the competent authority.

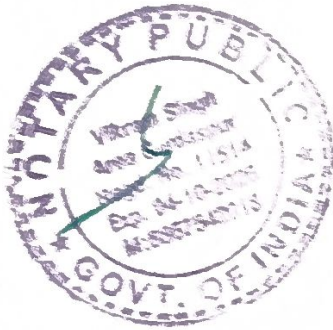

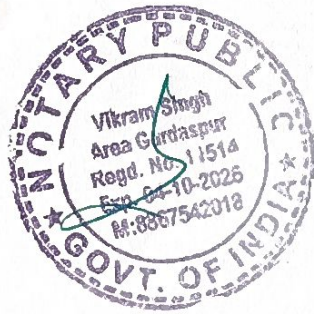
